- 2. Please pay fees for Skysign license permits as per rule no. 20 of Maharashtra Municipal Corporations (regulations and control of the display of skysigns and advertisement) Rules 2022.**
- 3. Adherence to the provision of Maharashtra Municipal Corporations (regulations and control of the display of skysigns and advertisement) Rules 2022.**
- 4. Rule no. 05 of Maharashtra Municipal Corporations (regulations and control of the display of skysigns and advertisement) Rules 2022 are binding/mandatory.**
- 5. GST has to be paid by the agency under reverse charge by service recipient under section 9 (3) of GST Act, 2017**
- 6. It is mandatory for the agency to pay it within 10 days after the receipt of challan.**
